2. Motion to Approve the Agenda Made by Gina, seconded by Tasha and approved by all.

ii. Basketball post-season update
a. Post-season survey- Gina received a lot of informal feedback from parents. The season was different than prior years since not in specific leagues. This allowed for more flexibility with scheduling. For next year the MS scheduling will be October through December with the Catholic School League and 3-4th grade teams will be January through March as part of the Holy Land League. In general parents commented about the long season, and liked having more home games.
b. Post-season coaches review was mixed desires regarding season length. expressed wanting to be in more tournaments and had feedback about equipment suggestions. Specifically requesting new/better balls as the current brand deflates quickly.
iii. Softball Updates
a. Jerseys and equipment inventory was taken. The team is needing 2 Ts , catcher's helmet and all equipment can be shared with the Rookie Ball team. Julie will be pricing out uniforms that will be dry wick polyester that can be reused. It will be mandatory for all players to supply their own pants.
