Board of Education Regular Meeting February 17, 2021 Minutes

- 1. The Regular Meeting of the Stockbridge Board of Education was called to order by President Brian Hermann at 5:00 p.m. Brian Hermann, Joanne Propson, Bill Parsons, and Ann Holzer were present. Sarah Willett, Dave Levknecht, and Jennifer Funk were absent. Mr. Marx and Mr. Meshak were also in attendance. Guest present included Julie Grebe.
- 2. Mr. Marx noted this meeting was posted in three public places per Wisconsin Statute 19.84(1) and on-line.
- 3. Bill Parsons moved and Joanne Propson seconded to approve the Consent Items including the Agenda, Minutes of the 01/21/2021 Regular Meeting, vouchers totaling \$42,828.16 and the January Treasurer's Report with revenue of \$210,605.75 and expenditures of \$214,346.37. Motion carried on 4 to 0 vote.
- 4. Forum Issues: Julie Grebe was present to introduce herself to the board. Julie is a candidate in the 2021 Spring Election.
- 5. Reports and Communications:
 - A. Mr. Meshak reported on the Speak Up, Speak Out program, the Calumet County Virtual Business Education Seminar, and the spring events planning.  - B. Can Collection: The board would like to consider moving the PTO can collection site to a new location.
