Minutes

1. The Regular Meeting of the Stockbridge Board of Education was called to order by President Bill Parsons at 5:00 p.m. Joanne Propson, Bill Parsons, Dave Levknecht, Jennifer Funk, Julie Grebe, Rachel Parsons, and Ann Holzer were present. Mr. Marx and Mr. Meshak were also in attendance. Guests present at the meeting included Jennie Zahringer, Christie Kuhn, Nikki Olson, Nathan Bowe, Wes Bunnell, and Ann Zitzelsberger.
2. Mr. Marx noted this meeting was posted in three public places per Wisconsin Statute 19.84(1) and on-line.
