## **Stockbridge School District**

Board of Education Regular Meeting April 16, 2025 Minutes

- 1. The Regular Meeting of the Stockbridge Board of Education was called to order by President Bill Parsons at 5:00pm. Bill Parsons, Jennifer Funk, Tracy Hanke, Rachel Parsons, Joanne Propson, Ann Holzer, and Amanda Cullen were present. Mr. Marx and Mr. Meshak were also in attendance. - 2. Mr. Marx noted this meeting was posted in three public places per Wisconsin Statute 19.84(1) and on-line.
- 3. Board of Canvassers Election Results & Recount: The original April 1<sup>st</sup> election canvas results were: Will Cummings 482, Rachel Parsons 280, Julie Grebe 357, Will Blackburn 359, and Scattering 4. A recount petition was received from Julie Grebe. The recount was held on April 8<sup>th</sup> at Calumet County Courthouse with the following results (same as initial canvas): Will Cummings 482, Rachel Parsons 280, Julie Grebe 357, Will Blackburn 359, and Scattering 4.
- 4. Oath of Office: Ann Holzer, Board Clerk, administered oaths of office to Will Cummings and Will Blackburn.
- 5. Ann Holzer moved and Amanda Cullen seconded to approve the Consent Items including the Agenda, Minutes of the 03/20/2025 Regular Meeting and 04/04/2025 Special Meeting, vouchers totaling \$90,145.12 and the March Treasurer's Report with revenue of \$192,758.65 and expenditures of \$260,967.83. Motion carried on a 7 to 0 vote.
- 6. Forum Issues: Ms. Lori Knoespel spoke on the National Honor Society induction ceremony; three students were inducted: Cooper, Craig, and Hunter. Kelly Phillips spoke about concerns within the 4K classroom. Malaree Gruetzmacher spoke about the bullying policy. Liz Bartel spoke about proposed surveys to gather parent and teacher feedback twice per year. Laura Shea spoke about concerns within the 4K classroom. Katie Warner spoke about why they chose to leave the school. Kayla Ecker spoke about concerns within the 4K classroom.
- 7. Reports and Communications:
  - A. Mr. Meshak reported on upcoming trips: the Junior & Senior class trip is on Friday, May 9<sup>th</sup> and the high school Washington DC trip is April 28-May 2.
