Minutes

1. The Regular Meeting of the Stockbridge Board of Education was called to order by Bill Parsons at 5:00pm. Bill Parsons, Tracy Hanke, Will Cummings, Joanne Propson, and Ann Holzer were present. Jennifer Funk and Will Blackburn were absent. Mr. Marx and Mr. Meshak were also in attendance. Guests present include: Lori Knoespel, Laura Shea, Tasha Huempfer, and Ashley Montour.
2. Mr. Marx noted this meeting was posted in three public places per Wisconsin Statute 19.84(1) and on-line.

Ann Holzer moved and Joanne Propson seconded to approve the Consent Items including the Agenda, Minutes of the 06/18/2025 Regular Meeting, vouchers totaling \$163,492.01 and the June Treasurer's Report with revenue of \$278,907.02 and expenditures of \$481,021.01.
