## **Stockbridge School District**

Board of Education Regular Meeting November 19, 2025 Minutes

- 1. The Regular Meeting of the Stockbridge Board of Education was called to order by Bill Parsons at 5:00pm. Bill Parsons, Tracy Hanke, Joanne Propson, Will Blackburn, Will Cummings, Jennifer Funk, and Ann Holzer were present. Mr. Marx and Mr. Meshak were also in attendance. Guests present included: Ms. Lori Knoespel, Ms. Carissa Salter, Nicole Landaiche, Mrs. Cathie Rohloff, Amy Kuhn, Mr. Matt Finnegan, Mrs. Ashley Montour, and Dawn Kempen.
- 2. Mr. Marx noted this meeting was posted in three public places per Wisconsin Statute 19.84(1) and on-line.
- 3. Jennifer Funk moved and Will Blackburn seconded to approve the Consent Items including the Agenda, Minutes of the 10/23/2025 Regular Meeting, vouchers totaling \$106,375.70 and the October Treasurer's Report with revenue of \$319,580.25 and expenditures of \$363,843.12. Motion carried on a 7 to 0 vote.

- 5. Reports and Communications:
  - A. Mr. Meshak reported on the National Honor Society's 12 Days of Christmas Food Drive, MACC Fund Clinic Christmas Toy Drive, annual review of ACP (Academic & Career Planning), and the IXL Assessment System. An update was given on winter sports along with other district events and an update on a survey. The Smart Girls Rock event was held on Wednesday, November 12<sup>th</sup> at Boldt.
  - B. Mr. Marx reported on increases to the health and dental plans beginning January 1<sup>st</sup>, 2026. The Food Service department is offering a free Thanksgiving meal for all staff and students on Thursday, November 20. The Food Service Department received a grant valued at \$1,445 from Dairy Farmers of Wisconsin. Mr. Marx shared a news article from Wisconsin Public Radio. Two donations were received from the 150<sup>th</sup> Anniversary Committee: \$200.00 for the Library and \$664.00 for the Teacher's Closet.
- 6. Board of Education Discussion:
  - A. Calendars The 2026-27 and 2027-28 school calendars are in draft form and being reviewed.
  - B. A request was received from substitute teachers to receive a full day of pay even when it is only a half day of school scheduled.
  - C. Retired Stockbridge Teachers would appreciate receiving an additional stipend per day when working as a substitute teacher.

Motion carried on a roll call vote of 7 yes to 0 no.
- 9. Ann Holzer moved and Will Cummings seconded to reconvene in open session. Motion carried on a 7 to 0 vote.
- 10. Wisconsin Association of School Boards (WASB) Matters:
  - A. Spring Election Bill Parsons, Jennifer Funk, and Joanne Propson are up for reelection during the Spring Election.
    - i. January 6, 2026 is the deadline to submit Declaration of Candidacy forms.
- 11. Forum Communication Amy Kuhn spoke about parental concerns. Dawn Kempen also spoke about parental concerns including concerns with follow through.
- 12. Board Member Communications
